DO YOU HAVE WHITE PRIVILIGES: creating awareness for teachers

How can you use these statements

As a test for all staff members:

Put the statements in "forms" or give it on a paper, so people can fill in the statements with true or false.

As discussion cards in teams

Put every single statement on a card, and put them in a bowl or jar. Every team member can pick a card and reflect on that statement. A group discussion can start.

As a way to stimulate the discussion

Put these statements on posters and every week you hang a poster with a new statement in the staff room.

- 1. I Have never been discriminated of my skin colour
- 2. I have never been rejected for a job application because of my last name
- 3. If I have a child with a different skin colour, nobody thinks that I am the nanny
- 4. If my child goes to secondary school, the advise will be based on grades not on my ethnical or cultural background
- 5. If I drive an expensive car, nobody will think that I bought it with drugsmoney or stolen money
- 6. If I lost the key of my bicycle and I force the key lock, nobody will think I am a thief
- 7. I can move freely through a shop, without being watched by security service
- 8. My name is regular pronounced right and I don't have to repeat it all the time or to explain where it comes from
- 9. I am not often questioned about things that people of my ethnic group do
- 10. In my city or town there's a building for my religion
- 11. If I send my child to a school with a religious signature, nobody says that I raise my child to become a terrorist or fundamentalist
- 12. I can decide whether I want think about racism or not
- 13. If I watch the tv or look in the papers, I see a lot of people like myself
- 14. When people talk about our national heritage or civilization, It's clear people of my colour has establish that
- 15. When I visit the hairdresser, I can easy find someone to do my hair
